Gary Koerner - Budget review

Overview highlights:

- Delaying installation fund
- \$51484 = unallocated cash reserves- very good place

## Revenue highlights:

- Hard to tell if on target with our ask for a one-time give and new virtual giving
- This first Sunday's virtual Share the plate was lower than usual- typically \$150 but this time \$50

## Expenses highlights:

- We under-budgeted office supplies a little
- Stewardship: All events in people's homes they covered the costs themselves
- We didn't really cover music- \$100 is not even one piano tuning and certainly no guest musicians

- RE- we hired someone for childcare- but now nowhere to use that person until we meet as a group
- \$32000 overall better than we budgeted. Budgeted \$10,000 loss but we're \$20,000 up

# Endowment proposal-

- Proposal: Investing the money we don't need liquid (capital development and endowment funds- total \$15000) into an investment account
  - the unitarian universalist common endowment fund
    - managed by UUA- socially responsible investing- keeps UU principles in play
      - socially responsible investing- divested from fossil fuels- based on a motion from the floor at GA
      - And use clout as investors to pressure companies to ask for socially responsible change- in connection with other socially responsible funds
      - Mix stock and bond fund
  - Jim Robison did a deep dive into this fund- he has the expertise to know
    - not do as well as some aggressive funds- but does decent and less aggressive- hopefully the low market is good for us- finance committee thinks its worth that risk and something they would like to do
- Gary can send link to their site if someone wants to look (beyond what finance committee did)
- Discussion:
  - *How liquid is this fund?*
  - o \$15000 making 0 seems a waste
  - Can we do anything w any more of our money
    - *Is credit union an option? (better interest rates? and maybe more in line with our values)*
    - Maureen made motion to approve the proposal of the finance committee; Ian seconded; unanimous approval
    - *Related: Who should be on the "authorized persons form"?* 
      - Signing authority- Marsha von Dessoneck, Gary, Koerner, Jim Robison

## 6:35 Stewardship Update

30-35 people not pledged yet - up to about 153000 in pledges- goal = about 170000 (20 or so have not responded to the follow up contact, but 18 of those have no pledge history with us at all)
